# ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

## SUMMARY

### Offer Price

- The Offer Price has been determined at HK\$1.65 per Offer Share (exclusive of brokerage fee of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

### Use of Net Proceeds from the Share Offer

- Based on the Offer Price of HK\$1.65 per Offer Share, the net proceeds from the Share Offer, after deducting the underwriting commission, selling concession and related listing expenses payable by the Company in the Share Offer, is estimated to be approximately HK\$202.8 million. For details regarding the use of net proceeds, please refer to the paragraph headed “Use of Net Proceeds from the Share Offer” in this announcement and the section headed “Future Plans and Use of Proceeds” in the Prospectus.

### Applications under the Hong Kong Public Offering

- The Offer Shares initially offered under the Hong Kong Public Offering have been significantly over-subscribed. A total of 14,529 valid applications pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS and through the **IPO App** or the designated website at [www.hkeipo.hk](http://www.hkeipo.hk) under **HK eIPO White Form** service for a total of 922,724,000 Offer Shares were received, representing approximately 59.04 times of the total number of 15,628,000 Offer Shares initially available for subscription under the Hong Kong Public Offering.
- Due to the over-subscription in the Hong Kong Public Offering, the reallocation procedures as described in the section “Structure and Condition of the Share Offer – The Hong Kong Public Offering – Reallocation” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Hong Kong Public Offering represent more than 50 times but less than 100 times of the number of Offer Shares initially available under the Hong Kong Public Offering, 46,872,000 Shares have been reallocated to the Hong Kong Public Offering from the Placing, so that the total number of Offer Shares available allocated to the Hong Kong Public Offering has been increased to 62,500,000 Shares, representing 40% of the total number of Offer Shares initially available under the Share Offer.

## **The Placing**

- The Offer Shares initially offered under the Placing have been slightly over-subscribed. A total number of 296,277,877 Shares have been subscribed, representing approximately 2.11 times of the total number of Offer Shares initially offered under the Placing. As the Offer Shares initially offered under the Hong Kong Public Offering have been significantly over-subscribed as mentioned above, 46,872,000 Shares have been reallocated to the Hong Kong Public Offering from the Placing. After the reallocation, the final number of Offer Shares under the Placing comprises 93,750,000 Offer Shares, representing 60% of the total number of Offer Shares initially available under the Share Offer. There were a total of 102 placees under the Placing. Furthermore, a total number of 8 placees have been allotted 10 board lots or less, representing approximately 7.8% of the total number of the 102 placees under the Placing. These placees have been allotted approximately 0.2% of the Offer Shares under the Placing.
- None of the Sole Sponsor, the Joint Bookrunners in respect of the Placing, the Joint Lead Managers in respect of the Placing, the Underwriters or their respective affiliates, companies and connected clients of the lead broker (if any) or of any distributors (as defined in Appendix 6 to the Listing Rules) has been placed with any Offer Shares for its own benefit under the Share Offer.
